

# Pack Leader, Plus... Home and Pet Care Guidelines

## Guidelines for Your Pets Sit/Walk

1. Be certain to have all food, supplements, treats and medications readily accessible and visible for the pet care provider.
2. Make sure your pet has necessary vaccinations as required by local authority.
3. For all pets that are walked on a leash in public areas or open spaces. Pack Leader, Plus... will not be held liable for injury or loss of pet(s) due to sudden or erratic behavior of pet causing it to become loose, pet(s) being attacked by another animal or liabilities arising from pet(s) attacking and injuring/killing another animal or person.
4. Pets that have access to the outdoors or are kept outdoors must have a secured area in which they are contained. It is recommended that you inspect your fencing, doors and windows as well as have an ID Tag on your pet. The Client agrees to release Pack Leader, Plus... of any liability for damages, injury/loss of pet(s) or to home or any other property/person/pets. **Pack Leader, Plus... cannot be held responsible for outdoor pet(s) escaping, getting loose or disappearing.**

**Client agrees that if pet(s) escapes/disappears, Pack Leader, Plus... is to notify Client and animal control and search for the pet(s) at an additional cost of \$25 per hour for a reasonable time.**

## Guidelines for Your Home

1. Be certain that all doors, windows and other points of entry to your home and yard are secured and in good repair. Pack Leader, Plus... cannot be held liable for items that blow away or come down such as fences, planters, lawn items, barbecues, flags, bird feeders, etc., or damages to these items caused by pets or visitors to the home such as gardeners or maid services.
2. It is recommended that you water all of the indoor and outdoor plants

once before leaving for three or more days.

3. If you use an alarm/security service, alert them that a pet care provider has been contracted. Give them Pack Leader, Plus'... name and telephone (636) 333-2224. Although not required, it is ideal to program an exclusive code, separate from that used by others, for use by the pet care provider.

**4. Have all supplies required for the pet visits accessible and visible: Extra light bulbs, cleaning rags, paper towels, sprays, brushes, leashes and collars, feeding and watering bowls, litter, poop scoopers, trash bins, etc. The less time pet care providers use looking for the items, the more time that can be spent playing and attending to your pet(s).**

5. Decide whether keys will be kept on file to enter your home and/or mailbox with Pack Leader, Plus... Keys are kept in a secured location for privacy and safety. If only keyless entry devices will be used to access that home, Client must keep a key for emergency use on the premises in a predetermined location known to the pet care provider. There is a \$25 key charge each time a special trip is made by your request for pick-up or return of keys.

### **Job Sharing**

Pack Leader, Plus... strongly discourages job sharing pet care provider assignments with friends, neighbors or others. If you wish to have another party share in caring for pets and home. Pack Leader, Plus... **MUST BE NOTIFIED** and reserves the right to refuse service. When authorized parties are job sharing. Client relieves Pack Leader, Plus... of **ALL LIABILITIES** that may arise from misconduct, negligence, poor judgment for pet and home situations, loss of keys, injury to pets or damages to home, theft or other circumstances that cannot be supervised or controlled by Pack Leader, Plus... **If another party is participating in care without our knowledge, Pack Leader, Plus... will terminate service immediately upon discovery.**
